



**Health and Safety Policy Statement**

CSM Project Management Ltd aims to act responsibly to ensure, so far as is reasonably practicable, the health and safety of its candidates whilst at work.


**CSM Project Management Ltd will:**

- o Ensure that senior management actively involve the workforce – including part-time and agency workers – as part of a developing health and safety culture.

**Each candidate has a duty to co-operate by:**

- o Complying with appropriate legal requirements and company health and safety rules.
- o Wearing and using the protective clothing and equipment provided.
- o Applying good housekeeping to work areas.
- o Reporting incidents or hazards which could lead to injury or damage.
- o Attending safety training in accordance with CSM Project Management Ltd requirements.
- o Working safely in the interests of themselves and others.

In addition to the basic Health and Safety arrangements outlined in the above policy, special procedures need to be adopted and applied in relation to railway work.
